Summary

Western civilization stands at a dead end of decline – both in the United States and in Europe. Europe 1950-2025 — Anatomy of an Illusion

3.1. From Marshall Aid to Institutionalized Technocracy

After the Second World War, Europe – physically and spiritually exhausted – became the target of American geostrategic reconstruction. The Marshall Plan, despite its economic effectiveness, was not just aid for rebuilding Europe, but also a mechanism for its political and ideological integration into the Anglo-American West. This marked the beginning of the redefinition of European independence – economic, political, and military – within the framework of transatlantic dependence.

Europe's post-war reconstruction was not merely a construction project – it was a reconstruction of consciousness. People, weary of totalitarianism and battlefronts, turned to cooperation, free trade, and shared rules. The Marshall Plan was more than American charity – it was a strategic move that enabled Europe to survive, but simultaneously initiated the process of dependency. The money came with conditions, and the conditions came with silence. The U.S. was not building Europe out of solidarity, but out of geopolitics. Those who listened carefully already heard: 'We'll give you the dollar infusion, you close the door to communism and stop bothering us with national interests.'

The European project, as conceived by Schuman, Monnet, and others, had noble aims – peace, cooperation, economic integration. But already in its early stages, elements of power centralization and bureaucratization began to emerge, which later became characteristic of EU institutions. Over time, the project of political integration started to drift away from the people and their real needs.

In the 1960s and 1970s, Europe sought its own path – the EEC was a collection of states competing with the U.S. while living in its shadow. Until the 1990s, there existed a kind of balance between national interests and the

common market, between democracy and bureaucracy, between industrial development and the welfare state. But with the fall of the Berlin Wall and the collapse of the Soviet Union, Europe lost its sense of balance – and began to believe the PR designed by the globalist oligarchy with its infrastructure and financial resources.

In the 1970s and 1980s, globalization further reshaped Europe's priorities. Instead of a common political identity, a governance structure emerged increasingly shaped by the consensus of globalist elites, not the will of the people. The European Commission, which was supposed to serve the member states, transformed into an almost independent entity with a political agenda aligned with the globalist oligarchy.

With digitalization and deregulation in the 1990s, the shift to a technocratic model of governance began. EU institutions, in cooperation with transnational corporations and consultancy giants like McKinsey, Deloitte, and others, started managing Europe in a way increasingly resembling a corporate-led state. (Policy Department for Budgetary Affairs 2022; Politico 2019). Public policies were designed based on models, analytics, and simulations – not democratic debates or electoral legitimacy.

Instead of building strategic autonomy, the EU embarked on soulless expansion. The inclusion of new countries was technical, cold, lacking sensitivity to cultural contexts, but with a clear agenda of interest-driven enlargement. Even Europeans themselves began to perceive integration as a bureaucratic process, not a common project. New institutions, new standards, new currencies emerged – but the soul faded. The single market became the holy grail, while the fundamental question was lost: Who is Europe, not just what does it produce.

With the Lisbon Treaty, Europe transformed into an institutional monster: democratic debates were replaced by trilogues, laws became technical acrobatics, and the parliament a space of symbolism, not decision-making. If you had a different opinion, you were regressive; if you mentioned sovereignty, you were a nationalist; if you pointed out problems, you were a Eurosceptic.

From my own experience, I recall an example when, at a European economic conference with over 300 participants from across the EU in 2006, I warned

about the completely inadequate economic policy that failed to support its own pharmaceutical industry to ensure the long-term strategic supply of quality medicines. I suggested that our competitiveness should be built on European technical, ethical, ecological, and quality standards, which would serve as an entry barrier for firms that do not meet them. The panel's response was rather dismissive, saying we couldn't move toward economic closure or protectionism. No one offered answers, let alone accountability when, a decade later, certain medicines started disappearing from the market because no one in Europe produced them, and foreign suppliers couldn't guarantee the necessary quality. The situation worsened during COVID, when shortages of many medicines emerged. Multinational corporations shifted to therapies with genetic and biological drugs, uninterested in postpatent classic medications. Public interest means nothing to them because it's not profitable. The situation is tolerable for now, but when the EU enters war with Russia and China – as we are constantly threatened – your children or even you, as soldiers on the front lines, will receive poor care. Not to mention the civilian population of the EU.

Thus, Europe transitioned from a continent of countries united by shared values to a strictly controlled technostructure, where social dynamics are subordinated to economic indicators and globalist directives. Instead of political debate – simulation of participation. Instead of democracy – regulated complexity. And all under the guise of progress, stability, and modernization.

And so, we arrive at the present moment: technocratic paralysis, where European bureaucracy regulates everything, but no one is accountable. Where rules are written by those who do not live by them. Where the entire system is designed to survive another scandal, another protest, another recession – each time with emptier eyes and a hollower sense of purpose. None of this is accidental; the globalist elite is creating the EU based on its own interests.

The Europe we have been building since 1950 will not collapse overnight. It is decaying slowly, like a fine salamander in the wrong climate – still gleaming on the outside, but soft and mouldy within, saturated with the compromises of decay. While we believed in the 'single market', 'sincerity of values', and 'peace as the foundation', the quasi-elites replaced national

cultures with trade, citizens with consumers, democracy with technocracy, truth with consolidated news.

This historical arc is the basis for understanding the current state: Europe has not developed in the direction its citizens desired, but in the direction dictated by the interests of the globalist oligarchy and their loyalists in the European Community – not only the EU bureaucracy but also national political elites of all stripes. Just consider your own environment – who among national politicians and media openly promotes Anglo-American quasi-culture, who opens the doors to their economic and political agendas. How their collaborationist actions resulted in their career advancement, in prominent positions in international institutions like NATO, the World Bank, the European Bank, or were sponsored by various foundations, always with a clear underlying interest to shape Europe according to their goals.

In truth, we did not build Europe. We built a system that gradually absorbed Europe – not as its soul, but as decoration. And because we remained silent, because we looked away, because we traded our inner compass for external markers, we now wake up in a Europe that talks about values but has no spine, that advocates peace but supports wars, that celebrates individual freedom but forgets the common good.

If this seems exaggerated, you haven't been paying attention. If it makes you uncomfortable, you're on the right path. That's why I write this chapter – to reveal where the illusion began, how it was sustained, and why many still consider it reality.

Compromise in politics can be a virtue – if it is grounded in constructiveness and responsibility. But in recent decades, compromises have turned into excuses. Systemic corruption, complete alienation of the political elite, and bureaucratic arrogance have led to the decay we now experience as confusion, disorientation, and a loss of future.

We Europeans are not the main culprits – except perhaps in our naivety. But until we recognize the psychological mechanisms of power, media illusions, and geopolitical reality, we remain trapped in a game we do not understand.
